3.2 Organizational Structure

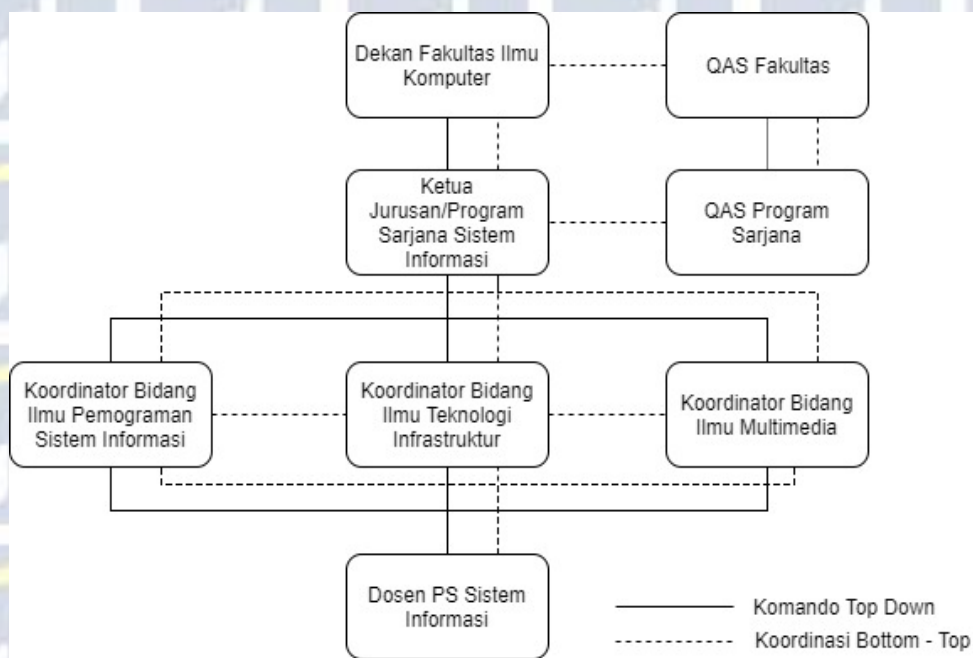


Figure 1 Organizational Structure of Information System Study Program

Following are the explanations and assignments of each in the organizational structure Figure 1:

1. Dean of the Information System Study Program Serves as Follows:

- 1) Formulate the academic policy of the Study Program and study program.
- 2) Formulate norms and benchmarks for organizing the Study Program.
- 3) Refining and approving the annual work program and budget plan from the Study Program.
- 4) Formulate an achievement assessment policy for the Study Program.
- 5) Upholding the norms that apply to the FIK academic community.
- 6) Responding and deciding on the settlement cases for violations of academic ethics and violations of rules that can defame the reputation of the Study Program / university, if the violation is committed by a lecturer or student.

7) Develop cooperation with external parties.

2. The Head Study Program of Information System is as Follows:

1) Develop a work plan and budget for the Information System Study Program as a work guide.

2) Drafting the development plan for the Study Program as Dean input material (further study, staff / instructors training, reports and administrative staff, student soft skills training).

3) Coordinate with the Science Field coordinator on curriculum evaluation, syllabus development and teaching plan for a semester.

4) Compile / evaluate the task of teaching of the lecturers every semester.

5) Coordinate with the Educational Field to monitor and evaluate the implementation of lectures to improve the quality of the Study Program.

6) Coordinate with the Educational Field about the implementation of the exam and the collection of exam questions.

7) Coordinating the implementation of student consultations related to academic and final assignments (practical work and thesis).

6. QAC is responsible for preparing and compiling SPMI documents that are in line with the social and cultural conditions of Universitas Internasional Batam.
7. The Internal Audit Coordinator is responsible for the implementation of internal audit.
8. The assigned Educational Field Coordinator (KBI) is as follows:
 - 1) Coordinate with lecturers related to syllabus review and teaching plans.
 - 2) Coordinate with lecturers regarding learning methods.
 - 3) Coordinate with lecturers about teaching materials and teaching source.
 - 4) Evaluating syllabus and teaching plan submitted by the lecturer.
 - 5) Evaluate the exam questions submitted by the lecturer.
 - 6) Monitoring and evaluate the implementation of lectures and the presence of lecturers.

7) Monitor and evaluate the suitability of teaching plans, teaching materials and reports plan.

8) Coordinate with lecturers regarding research methods and research implementation.

9) Coordinate with lecturers regarding the method of community service and the implementation of community service.

9. Information Systems Study Program lecturers have various Tridarma divisions divided into three parts, namely:
