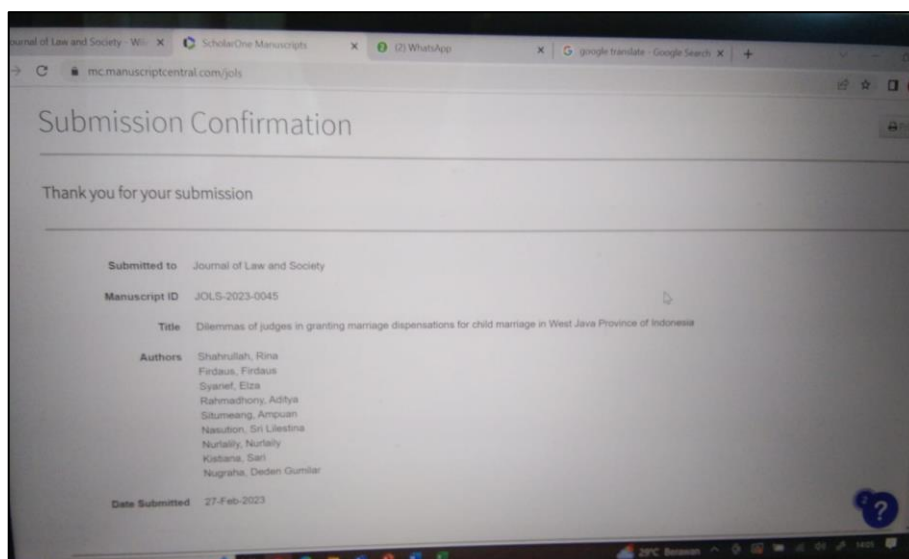

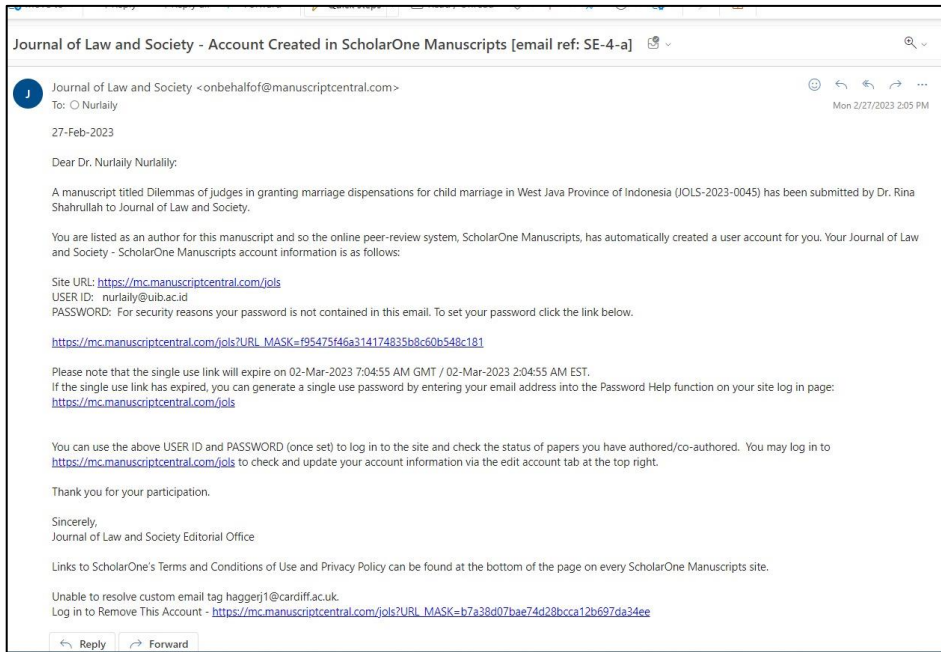

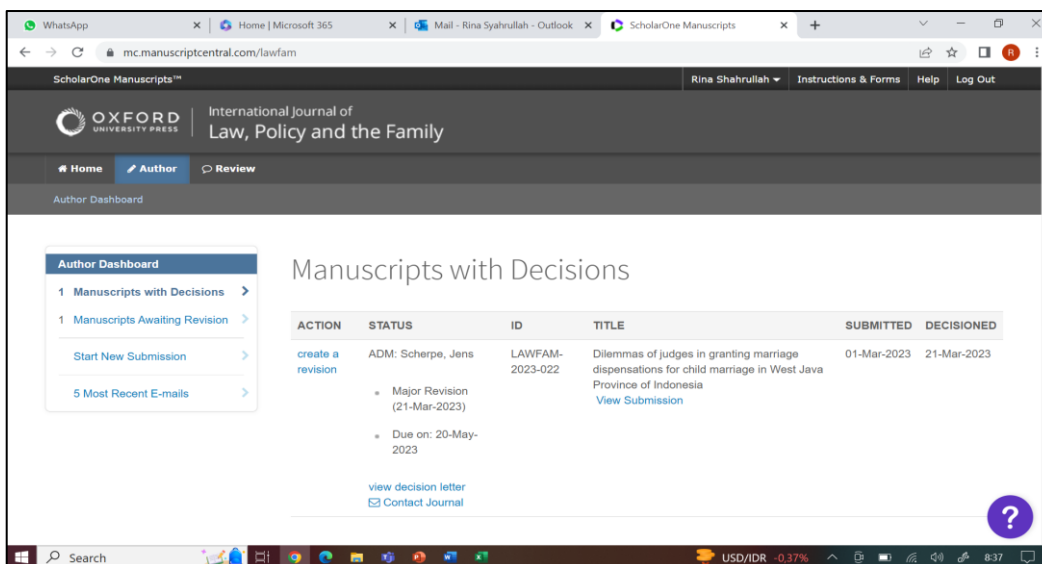

Comments to the Author

- Overall, the paper STILL needs careful proofing for English expression and grammar. During this process care should be taken to clearly distinguish the views of interviewees from those of the authors – a little unclear in places.
- The word 'santri' needs defining clearly on first use.
- Golden generation on p. 5 -6 : discussion a bit vague and confusing.
- Para beginning on p. 12 and running over to p. 13 needs editing to make it clearer. Discussion of 'rights of child a bit vague – consider adding text of the relevant provisions?
- Last para on p. 13 hard to follow.
- The additional text on p. 18 still does not explain the difference in rate of domestic violence between Tasikmalaya and Indramayu, because both cities are in West Java.
- Conclusion p. 22. This sentence seems to contradict itself: 'A Regional legal instrument is adequate in Tasikmalaya to prevent child marriage through the existence of the Regional Regulation of the Tasikmalaya regency concerning the Prevention of Child Marriage. However, its implementation is not yet successful in decreasing the number of child marriages'.

### Abstract

Child marriage remains common in Indonesia, particularly in West Java. The highest number of child marriages is seen in the Tasikmalaya and Indramayu regencies. We argue that although the Marriage Law has been amended and the age of marriage consent increased to 19 years to prevent child marriage, the law fails to eliminate child marriages as it allows for a marriage dispensation under
